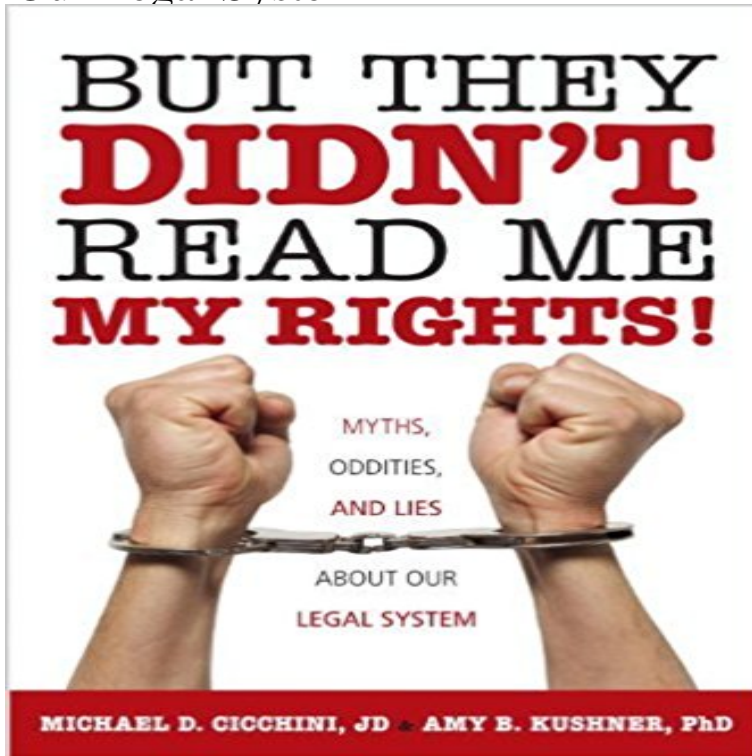


But They Didn't Read Me My Rights!: Myths, Oddities, and Lies About Our Legal System
