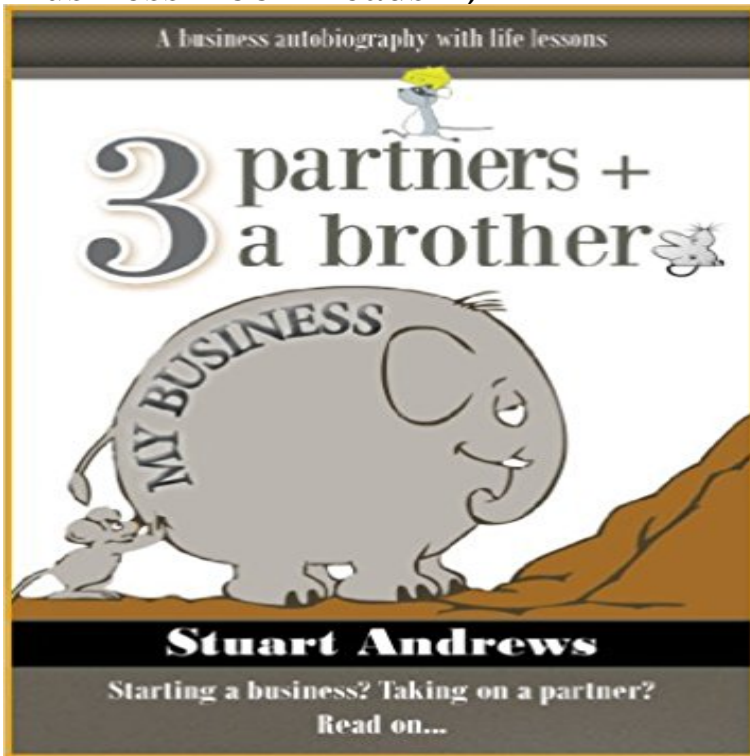


Business Start Up Help & Advice: 3 Partners & A Brother (One Hour Business Book Reads 1)
