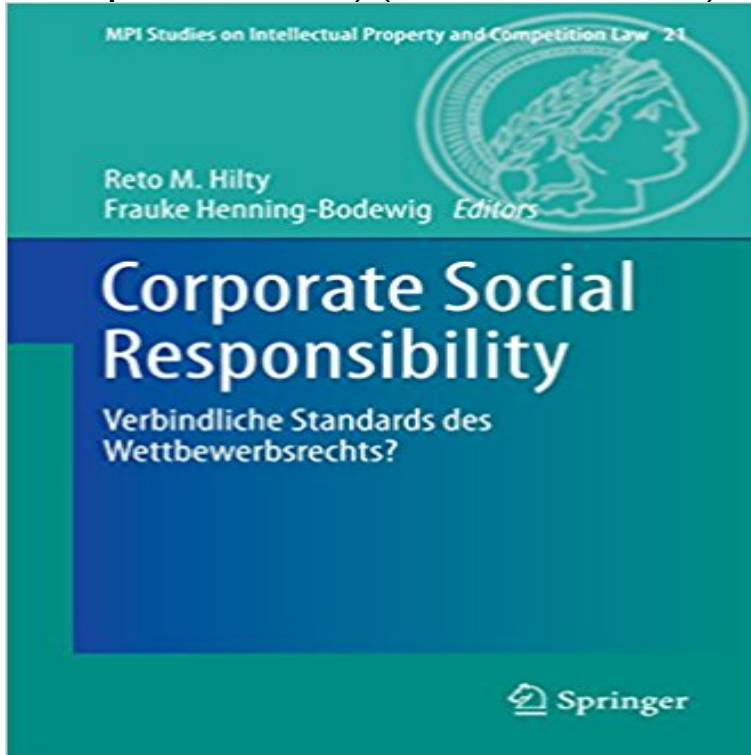

Im Zuge der Finanz- und Wirtschaftskrise wird verstärkt diskutiert, welcher Mechanismen es bedarf, um die Interessen aller Marktteilnehmer im Wirtschaftsleben zu wahren. Anders gefragt: Gibt es ein corporate right to lie, oder setzt das (deutsche, europäische, internationale) Recht Grenzen? Im Fokus steht hierbei das Recht zur Bekämpfung unlauteren Wettbewerbs, im deutschen Sprachgebrauch kurz auch Lauterkeitsrecht genannt, das in allen entwickelten Wirtschaftsnationen wenn auch mit unterschiedlichem Ansatz Markthandlungen unter dem Gesichtspunkt der Fairness überprüft. Die Autoren der Beiträge dieses Buches sind ausgewiesene Fachleute des Europa-, Wirtschafts- und Wettbewerbsrechts.
