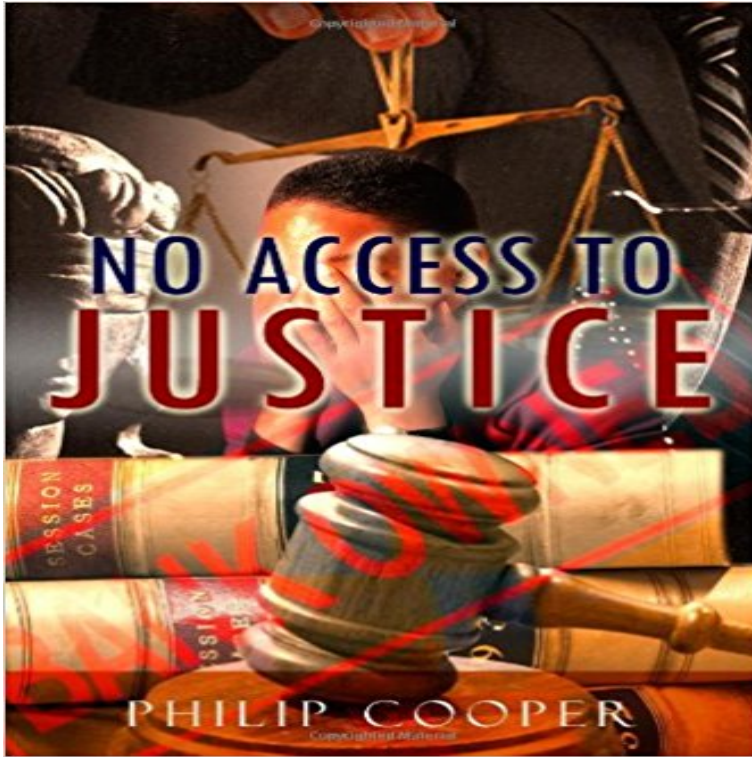


No Access to Justice
